#### The purpose and scope of this policy statement

Crayke CE Primary School works with children and families as part of its activities.

The purpose of this policy statement is to:

- protect children and young people who take part in services, events and activities, specifically those where photographs and videos may be taken
- set out the overarching principles that guide our approach to photographs/videos being taken of children and young people during our events and activities
- to ensure that we operate in line with our values and within the law when creating, using and sharing images of children and young people.

This policy statement applies to all staff, volunteers and other adults associated with our school including parents, carers and relatives.

# **Legal framework**

This policy has been drawn up on the basis of legislation, policy and guidance that seeks to protect children in England.

Summaries of key legislation and guidance is available on the NSPCC website.

#### We believe that:

- children and young people should never experience abuse of any kind
- we have a responsibility to promote the welfare of all children and young people and to take, share and use images of children safely.

## We recognise that:

- sharing photographs and films of our activities can help us celebrate the successes and achievements of our children and young people, provide a record of our activities and raise awareness of our organisation
- the welfare of the children and young people taking part in our activities is paramount
- children, their parents and carers have a right to decide whether their images are taken and how these may be used, regardless of age, disability, gender reassignment, race, religion or belief, sex or sexual orientation
- consent to take images of children is only meaningful when children, their parents and carers understand how the images will be used and stored, and are fully aware of the potential risks associated with the use and distribution of these images
- there are potential risks associated with sharing images of children online.

#### We will seek to keep children and young people safe by:

- always asking for written consent from a child and their parents or carers before taking and using a child's image
- always explaining what images will be used for, how they will be stored and what potential risks are associated with sharing images of children

- making it clear that if a child or their family withdraw consent for an image to be shared, it may not be possible to delete images that have already been shared or published
- changing the names of children whose images are being used in our published material whenever possible (and only using first names if we do need to identify them)
- never publishing personal information about individual children and disguising any identifying information (for example the name of their school or a school uniform with a logo)
- making sure children, their parents and carers understand how images of children will be securely stored and for how long (including how we will control access to the images and their associated information)
- reducing the risk of images being copied and used inappropriately by:
  - only using images of children in appropriate clothing (including safety wear if necessary)
  - avoiding full face and body shots of children taking part in activities such as swimming where there may be a heightened risk of images being misused
  - using images that positively reflect young people's involvement in the activity.

We will also develop a procedure for reporting the abuse or misuse of images of children as part of our child protection procedures. We will ensure everyone involved in our organisation knows the procedures to follow to keep children safe.

## Photography and/or filming for personal use

When children themselves, parents, carers or spectators are taking photographs or filming at our events and the images are for personal use, we will publish guidance about image sharing in the event programmes and/or announce details of our photography policy before the start of the event.

#### This includes:

- reminding parents, carers and children that they need to give consent for school to take and use their images
- prohibiting parents and carers from taking photos or filming events organised by the school, which take place in the school (e.g. nativity), on the school grounds (e.g. Sports Day) or in the local community (e.g. church services)
- reminding parents and carers ahead of an event verbally and in writing
- arranging an opportunity for parents and carers to take photos of their own child after an event where appropriate (e.g. nativity)
- asking for photos taken at events not to be shared on social media
- recommending that people check the privacy settings of their social media account to understand who else will be able to view any images they share
- reminding children, parents and carers who they can talk to if they have any concerns about images being shared.

#### Photography and/or filming for school use

We recognise that our school may use photography and filming as an aid in activities such as music or drama. However, this should only be done with school's permission and using our equipment.

Children, young people, parents and carers must also be made aware that photography and filming is part of the programme and give written consent.

If we hire a photographer for one of our events, we will seek to keep children and young people safe by:

- providing the photographer with a clear brief about appropriate content and behaviour
- ensuring the photographer wears identification at all times
- informing children, their parents and carers that a photographer will be at the event and ensuring they give written consent to images which feature their child being taken and shared
- not allowing the photographer to have unsupervised access to children
- not allowing the photographer to carry out sessions outside the event or at a child's home
- reporting concerns regarding inappropriate or intrusive photography following our child protection procedures.

# Photography and/or filming for wider use

If people such as local journalists, professional photographers (not hired by school) or students wish to record one of our events and share the images professionally or in the wider world, they should seek permission in advance.

They should provide:

- the name and address of the person using the camera
- the names of children they wish to take images of (if possible)
- the reason for taking the images and/or what the images will be used for
- a signed declaration that the information provided is valid and that the images will only be used for the reasons given.

School will verify these details and decide whether to grant permission for photographs/films to be taken. We will seek consent from the children who are the intended subjects of the images and their parents and inform the photographer of anyone who does not give consent.

At the event we will inform children, parents and carers that an external photographer is present and ensure the photographer is easily identifiable, for example by issuing them with a coloured identification badge.

If the school is concerned that someone unknown to us is using their sessions for photography or filming purposes, we will ask them to leave and (depending on the nature of the concerns) follow our child protection procedures.

#### If consent to take photographs is not given

If children, parents and/or carers do not consent to photographs being taken, we will respect their wishes. We will agree in advance how they would like to be identified so the photographer knows not to take pictures of them, and ensure this is done in a way that does not single out the child or make them feel isolated.

We will never exclude a child from an activity because we do not have consent to take their photograph.

## **Storing images**

We will store photographs and videos of children securely, in accordance with our safeguarding policy and data protection law.

We will never store images of children on unencrypted portable equipment such as laptops, memory sticks and mobile phones.

Crayke CE Primary does not permit staff and volunteers to using any personal equipment to take photos and recordings of children. Only cameras or devices belonging to the school should be used.

# Safeguarding Update - Photography

As part of our ongoing commitment to safeguarding and protecting the privacy of all children at Crayke CE Primary School, we are in the process of updating our photography and filming policy for all school events including church services and nativity performances.

On the following slide, please find a brief Q&A guide outlining our expectations and procedures regarding photography and filming during these events. To ensure the safety and comfort of every child:

- · Photography and filming during school events is to be strictly prohibited at all future school events.
- · Opportunities will be provided after the event for parents and carers to take photos or videos of their own children only.
- · Reminders about this policy will be given both verbally and in writing before and during events.

# **Photography Quick Read**

Follow your pathway and we grow together with confidence*		
Can I take photos or videos during school events such as church services or nativity performances?	No. Photography and filming during school events are <b>prohibited</b> to protect all children's privacy and safety. This includes the use of phones and cameras during the event.	
Why is photography during events not allowed?	This policy helps us safeguard children by preventing unauthorised recording and sharing of images, protecting children's privacy, and ensuring everyone feels safe and respected.	
Will I have a chance to take photos or videos of my child?	Yes. After the event, there will be designated opportunities for parents and carers to take photos or videos of their own children only.	
How will I know about the photography rules?	We will remind parents and carers both <b>verbally and in writing</b> before and during events about the no-photography policy to ensure everyone understands and follows it.	
What if someone takes photos or videos during an event without permission?	If this happens, staff will remind them that photography is not allowed. Persistent or serious breaches will be addressed according to the school's safeguarding and child protection procedures.	
How does the school manage photos and videos it takes?	The school only uses images with clear written consent from parents/carers and children. Images are stored securely and used responsibly, with children's safety and privacy as a priority. Names of children are never used alongside images, other than in exceptional circumstances where permission has been sought and approved.
